Subject **NEW INCOME LIMITS FOR THE FEDERAL POVERTY LEVEL (FPL) PROGRAMS, AGED AND DISABLED FEDERAL POVERTY LEVEL PROGRAM (A&D FPL) FOR COUPLES AND 2007 TUBERCULOSIS INCOME STANDARD AND RELATED ISSUES.**

Effective Date **January 1st, 2007**

Reference **ACWDL 06-39, 06-39E, 06-40, 07-04, 07-04E, 07-06, 07-07 and MPG Special Notice (SN) 06-16**

Purpose **The purpose of this letter is to inform of the following changes:**

- **An increase to the FPLs and Sneede V. Kizer prorated income levels for Section 1931(b)**
- **An increase in the A&D FPL Income Limit for a couple for the period of 1/07-3/07 and 4/07-12/31/07**
- **A change in the income disregard for A&D FPL**
- **An increase in the 2007 Tuberculosis (TB) Income Standard for individuals**
- **An increase to the Average Private Pay Rate (APPR)**

Background **The payment rate for Social Security's Supplemental Security Income (SSI) program increased as of January 1, 2007. The A&D FPL program limits cannot be less than the SSI/State Supplemental Plan (SSP) payment levels. The 2006 A& D FPL income limit for individuals remained the same through December 31, 2006. The SSI/SSP couple level is above the A&D FPL income limit, therefore, the A&D FPL program income limit for couples must be changed to match the SSI/SSP couple income level.**

Every year the Social Security Administration (SSA) Title II Cost of Living Adjustment (COLA) for all FPL based programs is disregarded until the FPLs are in effect annually on April 1.

	A&D FPL	The income disregard for couples is changed to \$361

Required Action

FPL Increase

Effective January 1st, 2007 workers will:

- Use the 2007 A&D FPL Income Limit for a couple,
- Use the 1/1/07-1/31/07 income disregard for A&D FPL,
- Use the 2007 Tuberculosis Income Standard for individuals,
- Use the 2007 QMB, SLMB and QI FPL when determining eligibility for individuals **without** RSDI Title II income.
- Use the 2007 APPR for calculating periods of ineligibility for transfers of property below fair market value.

**Required
Action
(continued)**

Effective March 1st, 2007 workers will use the 2007 QMB, SLMB and QI FPL when determining eligibility for individuals with RSDI Title II income.

Effective April 1, 2007 workers will:

- Use the new FPL figures provided in MPG Article 11, Appendices A and B when determining eligibility for the following special programs:
 - 100% FPL for children ages 6 to 19
 - 133% FPL for children ages 1 to 6
 - 200% FPL for children under age 1 and for pregnancy
 - A&D FPL
 - QMB
 - SLMB
 - QI
 - 250% Working Disabled (WD) Program
 - 1931(b)

Use the new prorated Sneede v. Kizer Social Security income limits for Section 1931(b) when determining eligibility.

Use the 4/1/07-12/31/07 income disregard for A&D FPL

**Lists of
affected
cases**

Lists will be distributed electronically to regions in order to identify applicants who may have been denied due to excess income and are now eligible due to the FPL increase. Attached to the electronic copy of this letter is the list for A&D FPL denied 1/1/07-1/31/07. The rest of the lists will be distributed electronically as soon as they are made available.

List	Evaluation Procedure
A&D FPL Programs denied 1/1/2007-1/31/2007	A&D FPL Program cases denied 1/1/2007-1/31/2007 are to be reviewed to determine if Medi-Cal eligibility exists for January 2007 ongoing using the new income standard and granted retroactively if applicable.
Medi-Cal (TB) Program cases denied 1/1-1/31/2007	NOTE: San Diego County does not have any affected TB program cases.
QMB/SLMB/QI Cases without RSDI Title II income Denied 1/1/07-1/31/07.	QMB/SLMB/QI Cases without social security income are to be reviewed to determine if Medi-Cal eligibility exists for January 2007 and ongoing.
QMB/SLMB/QI Cases with RSDI Title II income Denied 3/1/07-3/31/07.	QMB/SLMB/QI Cases with social security income are to be reviewed to determine if Medi-Cal eligibility exists for March 2007 and ongoing.

Automation Impact

- The reference tables for the January 1 – March 31, 2007 A&D FPL Income Limit for a couple, the 2007 income disregard for A&D FPL and the 2007 Tuberculosis Income Standard for individuals were updated in CalWIN February 5, 2007.
- The reference tables for the FPL increases effective April 1, 2007 will be updated in Calwin March 3, 2007.
- The Calwin Project will do a COLA run March 3, 2007, this action will run EDBC and auto authorize the results after the FPL tables are updated.
- After the COLA run, client correspondence for any automated changes created by the run will be sent in batch.
- The reference table for APPR will be updated shortly. This should not affect workers as all POI requests come through program.

Batch Exception list

As with previous COLA runs, there will be some cases that will not convert successfully during the COLA run. The worker must determine if an error exists, resolve it, run EDBC, and authorize the results. The list is attached to the electronic copy of this letter.
