Subject Clarification to the Refugee Medical Assistance (RMA)/Entrant Medical Assistance (EMA) Procedures

Effective Date Upon receipt

Reference MEM Letter 285
ACWDL 06-15

Purpose The purpose of this letter is to provide staff with the following clarifications:

- Refugees applying for RMA/EMA benefits are not required to provide a Social Security Number (SSN).
- Individuals who are identified as a Refugee, an Asylee, a Victim of Severe Form of Trafficking, or Cuban/Haitian Entrant are exempt from sponsored alien regulations.
- A referral to Healthy Families (HF) shall be completed for Refugee children, who appear to be eligible for HF and whose parent(s) have provided consent.

Background RMA and EMA are forms of humanitarian resettlement assistance that enables refugees' access to medical care. Revisions to the RMA/EMA procedures are included in this letter to reflect recent clarifications in policy regarding referral of refugee children to HF, SSN requirement and sponsored alien regulations.

Social Security Number Exemption A refugee applying for RMA/EMA benefits is not required to obtain, provide or disclose his/her SSN. Therefore, RMA/EMA applicants or beneficiaries shall not be denied, delayed, or discontinued from receiving RMA/EMA because of failure to provide SSN.

Sponsored Alien Regulations Exemption Individuals who are identified as a Refugee, an Asylee, a Victim of a Severe Form of Trafficking, or a Cuban/Haitian Entrant are not subject to sponsored alien regulations.

Healthy Families Referral Requirement

As a condition of eligibility to the RMA/EMA program, refugee children must be determined ineligible to zero share-of-cost (SOC) Medi-Cal or HF. A HF referral shall be completed for Refugee children who have been determined ineligible to zero SOC Medi-Cal but appear to be potentially eligible for HF and whose parent(s) have provided consent.

Until it is determined that the child will receive HF coverage, the child may receive RMA/EMA with no SOC

Staff are reminded to contact the CalWIN Help Desk to open a Service Request (SR) for any cases where the eligibility determination shown in CalWIN conflicts with the regulations detailed in this letter.
